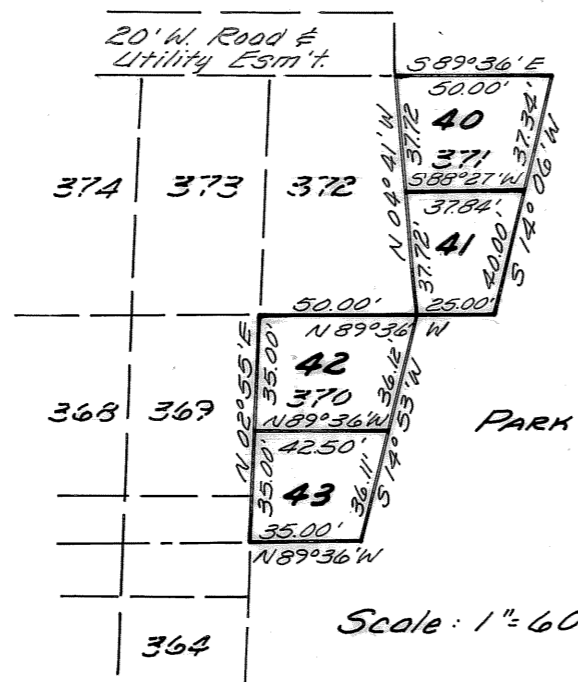

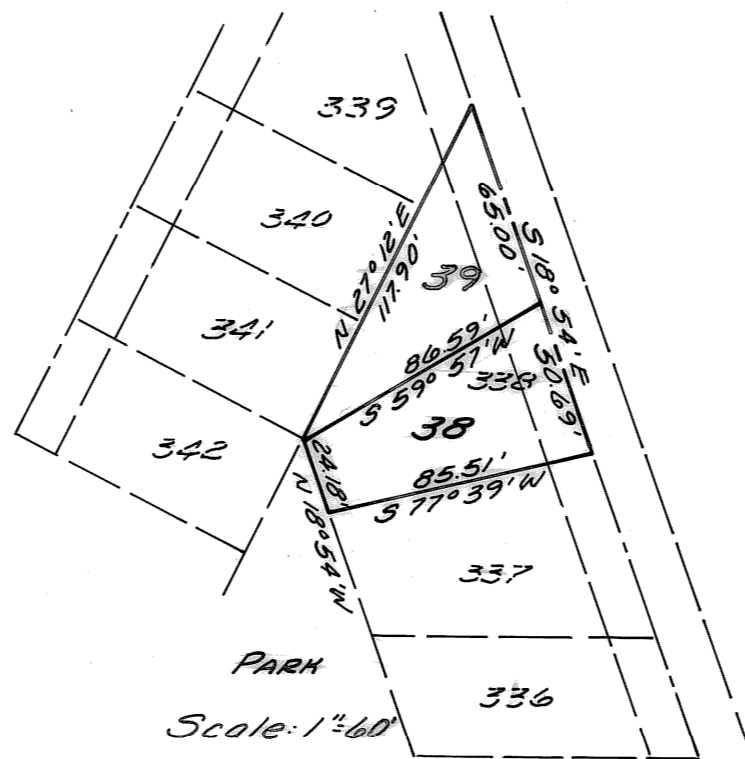

This plat is subject to conditions, restrictions, easements, covenants, and appurtenances filed with the Recorder of Deeds, Warren County, Missouri.

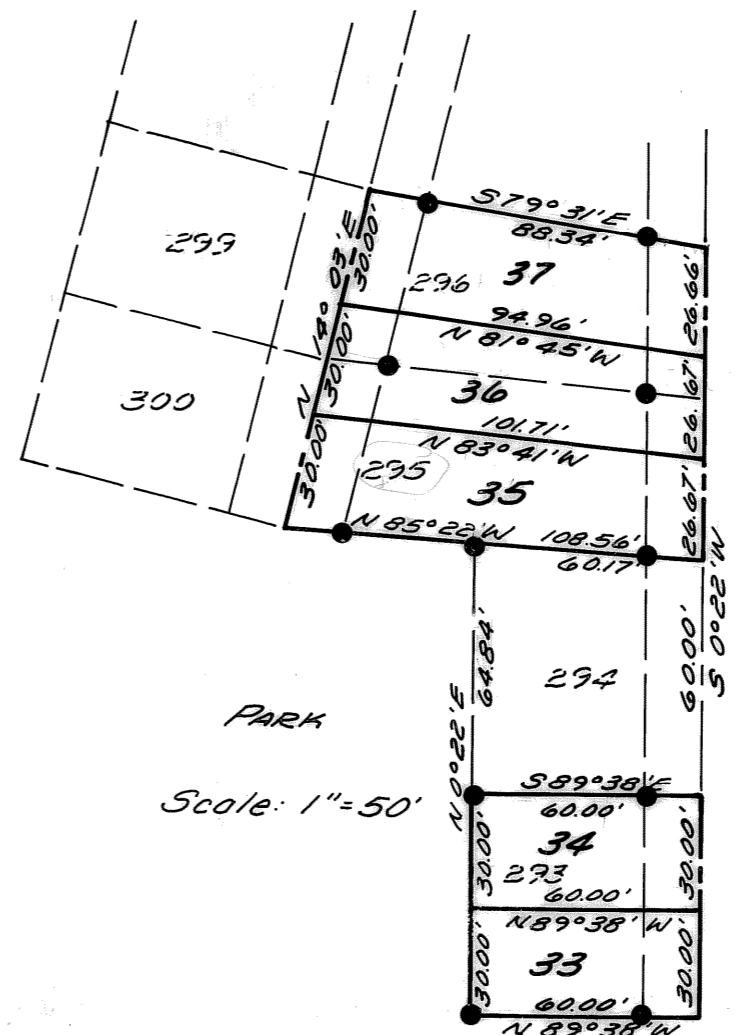

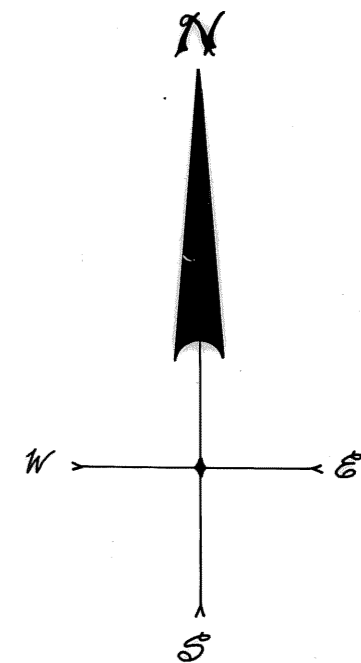

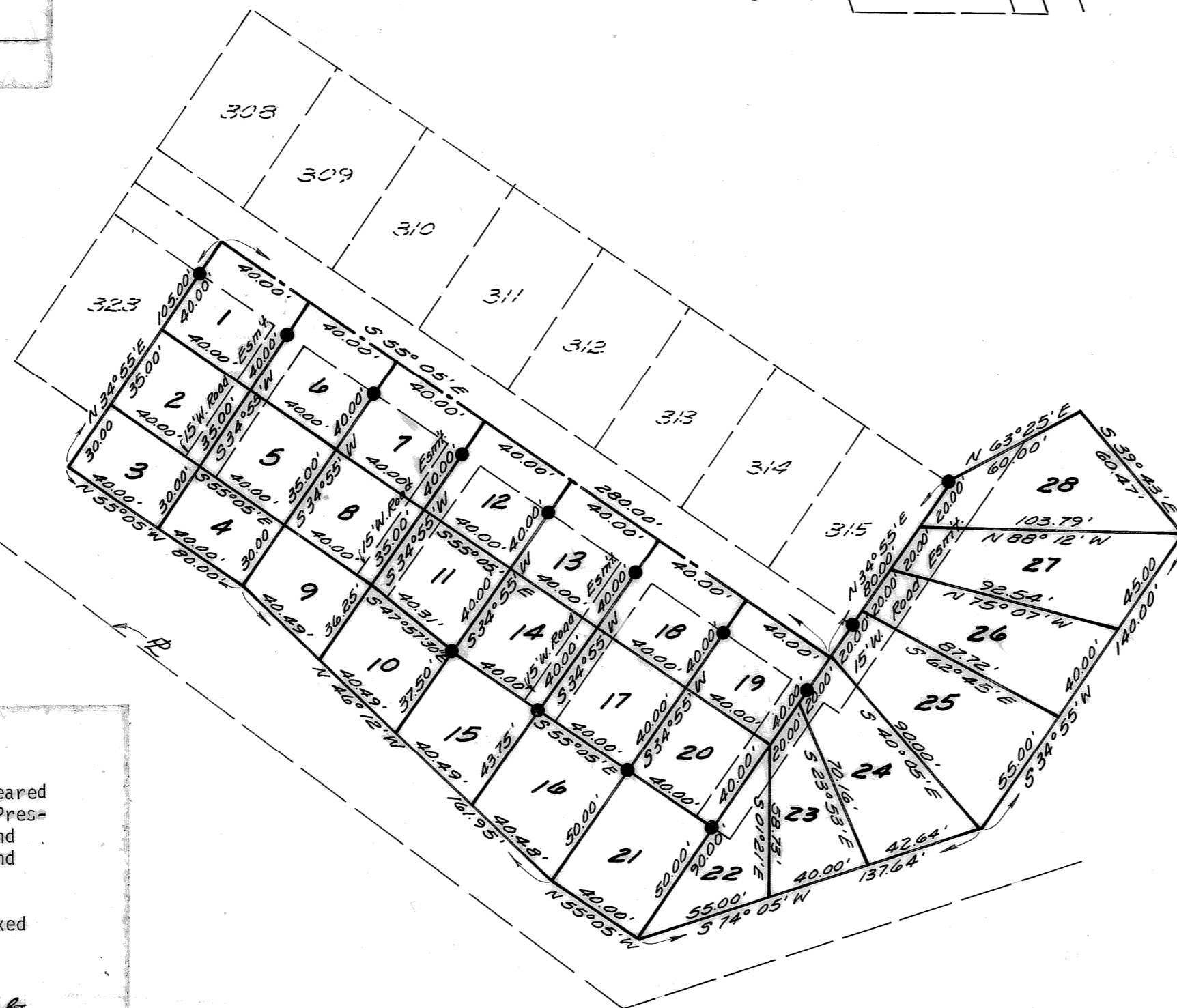
