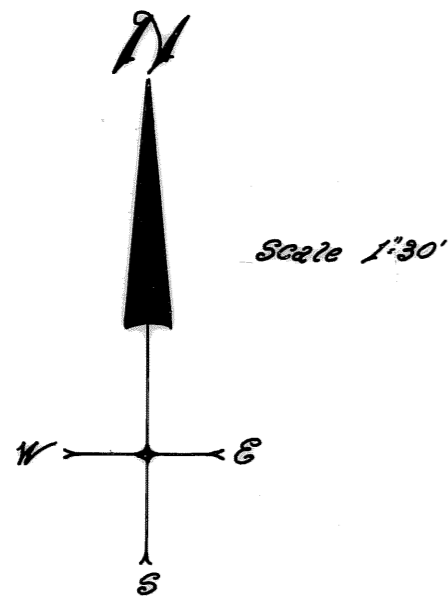


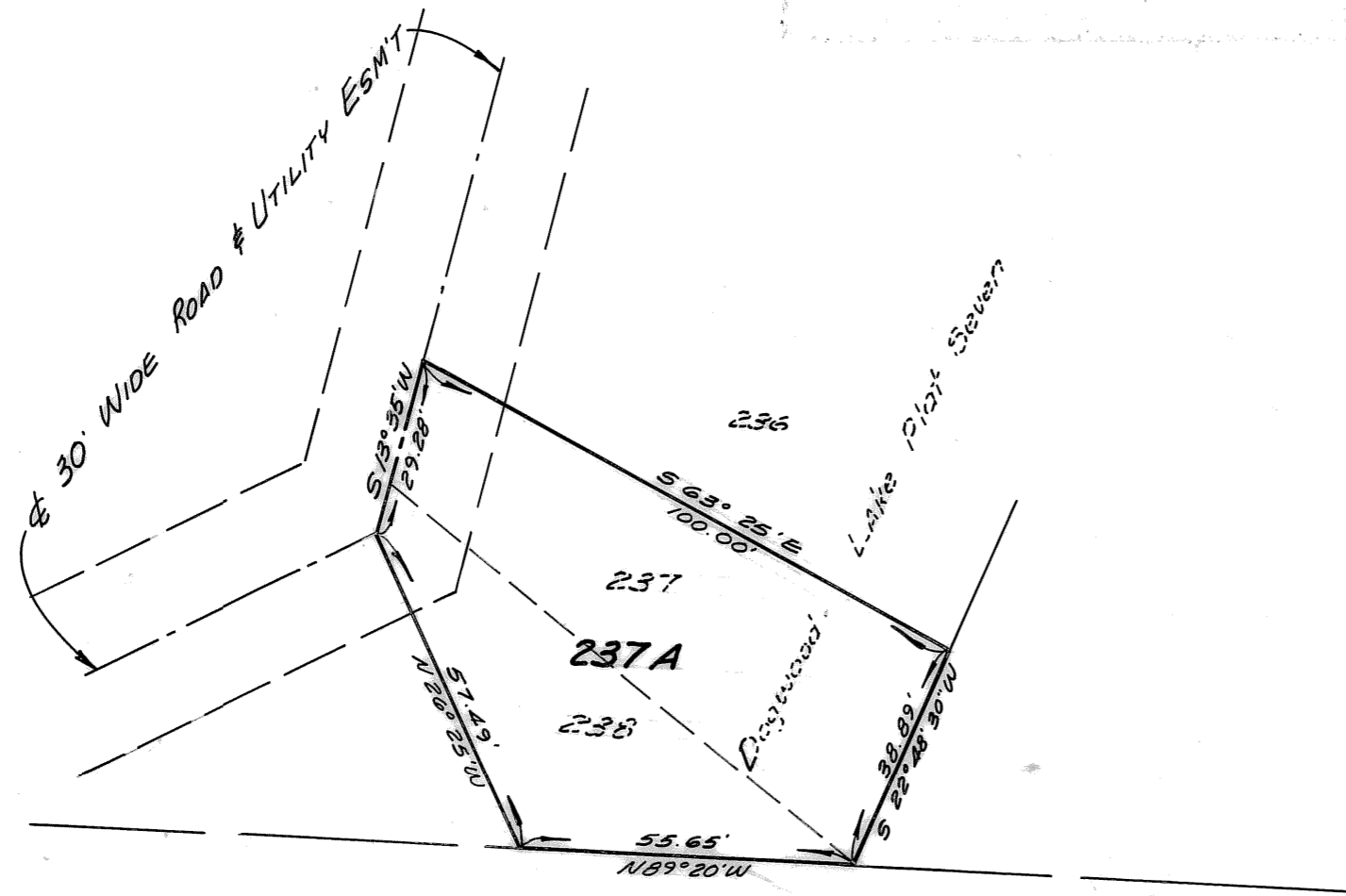
"DOGWOOD LAKE RE-SUBDIVISION OF LOT 237 & 238"
